Discuss the role NIMS plays in the area of medical education and training within Rajasthan.

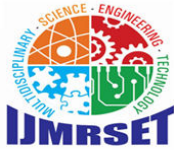
Analyze how NIMS embraces medical technologies and influences health care delivery.

According to Gupta and Sharma (2019), NIMS is an ideal institution that combines modern technology, research, and clinical practice to provide comprehensive care for patients.

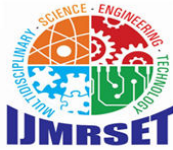

Gaps in Existing Literature:

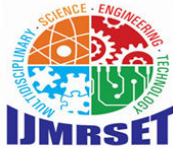
Despite a large body of literature discussing private healthcare in India and the activities of an entity like NIMS in enhancing the delivery of healthcare, there are some lacunae as well:
